

25 Year Limited Paint Warranty

Weatheredge Building Components herein referred to as “seller” warrants that within the continental United States and under normal outdoor atmospheric conditions, the exterior side of the Weatherbest 42 panel when coated with POLYDURE 1000 will not:

For Twenty-five (25) years, will not peel, flake or otherwise lose adhesion to an extent that is apparent on ordinary visual observation.

For ten (10) years, sidewall panels will not change color more than six (6) delta E hunter units and roof panels will not change more than seven (7) delta E hunter units when measured per ASTM D 2244 on clean surfaces after removing dirt, other surfaces deposits and chalk per ASTM D 3964

For ten (10) years, sidewall panels will not chalk more than a number eight (8) rating and roof panels will not chalk more than a number (6) rating when measured per ASTM D 4214, Method A.

Limitations of Warranty

This warranty does not apply to exposure of product to aggressive atmospheric conditions including but not limited to exposure to saltwater, continuous water spray, fallout or exposure to corrosive chemicals, fumes, ash, cement dust or animal waste or similar environments. Areas subject to run-off from lead or cooper flashings or in contact with such metallic substances or where corrosive fumes build up or condensate within the structure.

Buyer's Obligation

Buyer shall inspect the product upon delivery prior to installation to mitigate any expense involved in repairing, re-painting or replacing defective materials.

Buyer shall provide any records to seller which record the purchase date, delivery address, invoice number and other information which may be used by the seller to confirm products and quantities sold to the original buyer.

Transfers and assignments

This guarantee is extended to the buyer as the original purchaser from the seller only and is non-transferable and non-assignable.

Exceptions to warranty

Roof slopes of less than 1:12

Failure to provide proper drainage of water, condensation and other forms of moisture from all surfaces of panels

Damage due to improper cleaning of panel surface

Damage cause by direct contact with green or pressure treated lumber including fire retardant lumber.

Damaged caused by direct or close proximity of the panel to damp insulation, soil or vegetation.

Damaged caused by cutting with an abrasive blade or improperly shearing which damages coating

Merger

Oral statements made by the seller's representative are not warranties and shall not be relied upon by the buyer. This written warranty constitutes the final, complete and exclusive expression of the terms of the parties' agreement. Any modifications to this warranty shall be made in writing and shall be signed by an authorized representation of the seller.

Validation

To be effective: Seller must receive a fully executed copy of the warranty within 1 year of the date of shipment of material from seller and seller will have no obligation unless seller has been paid in full for all materials.

Exclusive remedy

Sellers total liability is expressly limited to the purchase price of the defective materials and shall not be liable for any losses, damage or expense caused directly or indirectly, resulting from the use of the defective product. Seller shall have the right to repair, repaint or replace defective merchandise and in no event be liable for any costs which exceed the original buyer's cost of the defective merchandise.

Exclusive of warranties

The express warranties and remedies stated herein are the exclusive warranties and remedies applicable to the products. All implied warranties, including any implied warranty of merchantability or fitness for a particular purpose, are expressly excluded.
